

Geothermal Heat Pump Equipment Requirements

Geothermal Heat Pump Equipment with Electric, Oil, LP Backup: \$750

• Limited to customers of participating electric utilities.

Geothermal Heat Pump Equipment with Natural Gas backup: \$1,000

Limited to customers of participating natural gas and electric utilities.

Geothermal Heat Pump Requirements:

- Equipment must have a coefficient of performance (COP) equal to or greater than:
 - 3.6 for a Water-to-Air Equipment
 - 3.1 for a Water-to-Water Equipment
 - 3.6 for a Direct Ground Exchange (DGX)
- Equipment must have an energy efficiency ratio (EER) rating equal to or greater than:
 - 17.1 for a Water-to-Air Equipment
 - 16.1 for a Water-to-Water Equipment
 - 16.0 for a Direct Ground Exchange (DGX)
- Large commercial (i.e., three-phase) units are ineligible under this application. Contact Focus on Energy for more information.
- A Pre-Qualified Equipment List is available at focusonenergy.com/geothermal.
- Installed equipments must include an air cooling option.
- Equipment must be the primary heating and cooling source for the site.
- Rebate cannot exceed cost to customer.
- Equipment must be purchased new. Resale equipment, new parts installed in existing equipment, or equipment that is rebuilt, rented, received from insurance claims, received from a warranty, or won as a prize does not qualify.
- Equipment must be installed by a qualified contractor.
- Rebates paid on this application cannot be claimed on another Focus on Energy application. Similarly, rebates can only be paid to one person or entity.
